Attached is our Issue Notification confirming that this patent will grant as US Pat No. 9,229,006 on Jan 05, 2016.

The claims encompass methods of making water-soluble, stable fluorescent PEGylated alkanethiol-coated quantum dots, as well as compositions comprising an organic phase comprising quantum dots and PEGylated alkanethiol in contact with an aqueous phase comprising water-soluble, stable fluorescent corresponding PEGylated alkanethiol-coated quantum dots.

The allowed claims encompass essentially all our originally-submitted claims and we received no restriction.
